Dear Claudio,

We had a meeting of the Danish delegation in UEMO last evening during which a number of relevant items were discussed, as follows:

1. GP 2000 Program. We assume that you are now concluding your discussions with ESGP/FM about the exact form of the program for this conference to be held in conjunction with the UEMO meeting in May. Our delegation -- noting your preliminary idea that the conference be divided up into five topics -- discussed how they thought this might be usefully set up and would like to come forward with the following program suggestions:

- a. Specific training for general practice
- b. CME (including the questions accreditation, reregistration etc.)
- c. Quality Assurance
- d. Prophylaxis
- e. The future role of general practice in Europe

Our delegation thought it might be useful to have two speakers on each of the first four topics -- one from UEMO and one from ESGP/FM, while the last topic seemed most relevant to have covered by a representative of the European Commission.

The delegation hopes that these suggestions might be of use to you and looks forward to hearing as soon as possible about your decisions on the program.

At the same time, as I will be in London tomorrow to discuss technical matters of the Reference book content, I hope very much that you might be able to give me an indication of the five topics you would envisage in order that the reference book content can be organized to correspond with that.

2. You had mentioned a meeting that you thought of organizing in Florence on March 24th. But I was not certain whether you had meant a meeting of the Presidency (i.e. PResident, Vice PResidents, etc) or an actual meeting of all the heads of delegations. Our delegation would be eager to know more about the plans for this meeting, if you still have this in mind.

I will try to telephone you during the day today, but hope to have your email response before the end of the day as well in order that I may it as guidance for my meeting in London tomorrow.
