Eirik Bø Larsen, born 13.06.55 in Bergen, Norway
Married, 2 daughters age 21 and 24 years

Authorized physician since 1982, specialist in general practise/family medicine since 1989.
General practise at Dokka, a small city with 7000 inhabitants in Norway since 1986, still working in the same practise with 2 other GP's and 1 trainee.

Teacher of medical students in the University of Oslo 1990 - 2003

Elected representative for GP's in Dokka since 1989

2 years assistant chairman, and 4 years chairman for all members of the Norwegian Medical Association in the county of Oppland, Norway (1992 – 1998).

For 6 years a member of the board of the Norwegian Association of General Practitioners (Aplf) 1996 - 2001.

1992 – 2001 member of the General Assembly of The Norwegian Medical Association.

2002-2003 member of the election committee for the board of The Norwegian Medical Association.

2005 – 2009 leader of the election committee for the board of the Norwegian Association of General Practitioners.

A member of several committees within the Norwegian Medical Association. (Among others a committee for bettering GP's on call duty services, a committee for bettering the cooperation between The Norwegian Medical Association and The Association of Norwegian Insurance Companies, different committees/delegations for negotiations with Government (salaries, introduction of the new list system for general practise, etc.)
